Applications are encouraged from healthcare (e.g. clinicians, nurses, pharmacists) or allied (e.g. academic researchers, laboratory technicians) professionals who are seeking funding for a research project or initiative that is aligned to the goals of the Fellowship/ Medical Grants Programme.

Projects can be part-funded through the Fellowship/ Medical Grants Programme, and we actively encourage applicants to seek funding through a wide range of sources. We can also support both new and ongoing projects that have a defined end date (typically within 12 months of starting) or where completion of the project is not contingent on further funding from the Fellowship/ Medical Grants Programme.

WHAT PROJECTS CAN WE SUPPORT?

The Fellowship/Medical Grants Programme is looking to support projects and initiatives which ultimately lead to an improvement in patient care. Priority will be given to those projects that focus on patients with breast cancer (especially triple-negative breast cancer) and urothelial cancer.

This can include, but is not limited to, activities such as:

- Audits or registry reviews assessing patient profiles, disease outcomes and treatment patterns
- Setting up new infrastructure for better diagnosis or detection of disease, or prediction or monitoring of safety and efficacy outcomes to treatment including increased disease awareness in primary care and amongst members of the public
- Establishing novel patient support programmes or tools
- New protocols to facilitate improved efficiency in patient care pathways
- Frameworks to improve monitoring of patient-reported outcome measures or quality of life instruments or educational tools for patients and carers

We particularly welcome any project that seeks to reduce inequalities in access to healthcare and outcomes.

Projects which fall **outside of the scope highlighted above**, but which will add clinical value, or which investigate an area of unmet need can also be submitted and will be reviewed on their merit.

Please note that we cannot accept any applications which generate specific patient clinical outcomes (either classified as interventional or non-interventional studies according to EUDRACT criteria). These fall under the category of a clinical trial and, as such, will be considered out of scope of the Fellowship/Medical Grants Programme.
